- Monitors and participates in audit programs
- Undertakes SQE audits to ensure compliance with Integrated Management System

- Ability for data and statistical analysis to identify SQE trends and input into monthly reports
- Updates SQE plans and procedures according to the instructions of the SQE Director
- Provide advice and mentor staff in the development of Safe Work Method Statements, risk assessments and permit to work processes
