



# Safety Quality Environmental and Risk Manager (Stage 3)

## **Position Purpose:**

Support Keolis Downer (KD) with respect to workplace health and safety and risks associated with the construction and mobilisation of the Gold Coast Light Rail Stage 3 extension to the light rail system.

# **Position Responsibilities**

Co-ordination of quality and risk activities relating to the fulfilment of KD obligations to participate and influence design outcome to provide a light rail system which is safe and accessible for passengers and KD staff in the line of their duties. Duties include:

- Representing KD interests at external technical design review meetings and preparation of WVR (Work Verification Records) with contractors and GoldlinQ;
- Ensure all design development is in accordance with PSR & O&M requirements;
- Attend joint hold and witness point inspections also attended by KD's client, GoldlinQ, the Independent Verifier
  and various construction quality representatives to determine whether design has adequately incorporated
  safety, quality and risk mitigation as necessary;
- Represent KD at FAT, SAT, SIT testing as required;
- Represent KD at all internal and external meetings as required and coordinate with the D&C contractor any interface arrangements that could impact safety, particularly UNH, BBS and Depot interfaces;
- Ensure all O&M manuals, spares, asset registers, safe working instructions, system site, as built drawings including training and familiarization are received and validated prior to completion and handover;
- Provide advice and direction relating to safety in design and installation;
- Prepare and develop all management of change documents including risk assessments, cost impacts and modifications to align with both D&C3 and GoldlinQ change management project processes;
- Assist in the development of system site drawings and update of the permit to work system in conjunction with internal departments to reflect the stage 3 extension including amendments to the KD induction training program;
- Provision of a handover report demonstrating that due diligence has been undertaken and to signify that the system can be accepted into operation; and
- Ensure the Operational Risk Register is updated and managed in conjunction with the KD internal HSQE team.

- Work as a Rail Safety Worker Category 2 (safety critical worker);
- Proven experience in relation to project quality management procedures;
- Proven experience in identifying, quantifying and controlling risk;
